In addition, we have assisted federal agencies in streamlining environmental laws and regulations for railroad projects. For the Federal Railroad Administration (FRA), we prepared a congressional study examining ways to streamline compliance with the National Historic Preservation Act (NHPA); for the U.S. Department of Transportation's Volpe Center, we developed NHPA Section 106 exemption language included in the FAST Act; and for the FRA and the Federal Transit Administration we are assisting with the exemption for railroad and rail transit rights-of-way.
